Affected Facility	Corrosion Companies, LLC 3725 Grant Street, Suite 3 Washougal, WA 98671
Description of Facility	Corrosion Companies Inc. operates a fiberglass manufacturing facility that utilizes filament winding, hand lay-up, and spray lay-up technical for both resins and gel coats. The facility manufactures fiberglass components, such as pipes, pipe fittings, equipment housings, and flanges, as well as larger products, such as tanks or scrubber bodies.
Source Designation	<u>Natural Minor</u> The facility is a stationary source subject to review under SWCAA 400-110. Facility emissions are less than 100 tons per year (tpy) of any single criteria pollutant, less than 10 tpy of any single hazardous air pollutant, and less than 25 tpy of any combination of hazardous air pollutants.
Purpose of Application	SWCAA has received a permit application to obtain approval to operate the facility; the facility did not request, nor receive an ADP prior to construction. The application has not yet been reviewed to determine if it is administratively complete. The SWCAA permit writer identified below will be reviewing the application to make a determination of completeness and, if necessary, make a request for additional information. A copy of the application will be available to the public when the application is determined to be complete.
Affected Pollutants	The proposed permitting action is expected to impact emissions of the following pollutants: <i>Nitrogen Oxides, Carbon Monoxide, Particulate Matter, Volatile Organic Compounds, Toxic/Hazardous Air Pollutants</i>
Public Comment Period	No public comment period for the draft permit is currently scheduled. A 30-day public comment period for the draft permit may be provided upon written request pursuant to SWCAA 400-171(3).

A public hearing will be held if the Executive Director determines that significant public interest exists.
