Affected Facility	Vigor Works 4400 SE Columbia Way, Vancouver, WA 98661	
Description of Facility	Vigor Works proposes to operate a new metal fabrication and spray coating operation at the former location of Christensen Shipyards. The proposed facility will operate in conjunction with existing Vigor Works operations located in the Columbia Business Center industrial park.	
Source Designation	<u>Minor</u> . The proposed facility will be a stationary source subject to review under SWCAA 400-110. Facility emissions will be less than 100 tpy of any single criteria pollutant, less than 10 tpy of any single hazardous air pollutant, and less than 25 tpy of any combination of hazardous air pollutants.	
Purpose of Application	SWCAA has received a permit application for installation of a metal fabrication and spray coating operation at the above described facility. The application has not yet been reviewed to determine if it is administratively complete. The SWCAA permit writer identified below will be reviewing the application to make a determination of completeness and, if necessary, make a request for additional information. A copy of the application will be available to the public when the application is determined to be complete.
