Description of Facility	Swanson Bark receives, grinds, blends, and screens wood, brush, and soil-based materials. The facility sells and ships bark, soil blends, mulch, hogged fuel, and rock products.	
Source Designation	<u>Nonroad Engines.</u> The proposed facility operates nonroad engines subject to review under SWCAA 400-046.	
Purpose of Application	SWCAA has received a permit application for operation of diesel engine powered material processing equipment at the above described facility.
