

PUBLIC NOTICE

Notice to the public is hereby given that the Southwest Clean Air Agency (SWCAA) is providing a 30 day public comment period for the preliminary determination to issue Air Discharge Permit / Nonroad Engine Permit 14-3112 to Millennium Bulk Terminals Longview, LLC. This preliminary determination approves modifications to existing bulk material handling operations, operation of an existing emergency diesel engine, and use of portable diesel engines for temporary projects at a bulk material handling facility located at 4029 Industrial Way in Longview, Cowlitz County, Washington. Proposed modifications will not change the nature of the facility or type of materials handled. Proposed engine operation will be limited, but does increase potential facilitywide emissions. Copies of the preliminary Air Discharge Permit and associated Technical Support Document are available for review at 11815 NE 99th Street, Suite 1294, Vancouver, Washington, Monday through Friday from 7:00 a.m. to 5:30 p.m. Electronic copies are available for review in the permit section of SWCAA's internet website (www.swcleanair.org/PermitsPrelim.html). This material will be made available in other media, if necessary. All written or oral comments must be received by SWCAA within thirty (30) days after this publication. Final action by SWCAA to approve, modify, or deny the proposal will be taken within ten (10) days after the close of the comment period. If there is significant public interest, a public meeting may be held at the discretion of the agency's Executive Director.




