Affected Facility	Northwest Motor Sales and Service 1331 Baltimore Street, Longview, Washington 98632	
Description of Facility	This facility repairs and reconditions various sizes of industrial electric motors for customers. The processes include burning off old wiring, case shellac and moisture from motor cases, winding armatures, replacing bearings, rebuilding the motors and finally spray coating them.	
Source Designation	<u>Minor</u> . The facility is a stationary source subject to review under SWCAA 400-110. Facility emissions are expected to be less than 100 tpy of any single criteria pollutant, less than 10 tpy of any single hazardous air pollutant, and less than 25 tpy of any combination of hazardous air pollutants.	
Purpose of Application	SWCAA has received a permit application for relocation of an existing motor repair facility from 1341 Industrial Way in Longview to the above described address. The application has not yet been reviewed to determine if it is administratively complete. The SWCAA permit writer identified below will be reviewing the application to make a determination of completeness and, if necessary, make a request for additional information. A copy of the application will be available to the public when the application is determined to be complete.
